TERMS AND CONDITIONS FOR DEMOLITION OF SHEDS / BUILDINGS AND TAKING OUT THE MATERIALS ARE AS UNDER:-

- 1) Details of e-Auction process are as mentioned on Page No.2 which is binding to the Participants (Bidder).
- 2) The cost of the prescribed blank e-Auction form is of Rs.1,500/- (Rs. One Thousand Five Hundred only) each which is non-refundable.
- 3) Interest free EMD amount of Rs.15,00,000/- (Rs. Fifteen Lac only) required to be paid by D.D. of Nationalized Bank. The EMD and Cost of e-Auction form Rs.1,500/- (Rs. One Thousand Five Hundred only) should be paid by way of separate Demand Draft/Pay Order only, drawn on Schedule Bank and be drawn in favour of "MAHARASHTRA STATE TEXTILE CORPORATION LTD." payable at Mumbai.
- 4) While submitting the e-auction documents, it is binding on the bidder to put his signature on every page and in case, there is a correction in writing, then bidder should put their signature on that place. Likewise, it is necessary to put signature on page No.3 to 15 of e-Auction conditions and after it's scanning to upload the documents.
- 5) e-auction documents submitted without signature on all the pages will not be accepted. Likewise any tender condition is modified or bidder puts his additional conditions then such tender document shall liable to be rejected.
- 6) As per Information and Technology Act, 2000, the bidder should get Digital Certificate (both signing and encryption) from any certifying authority by paying prescribed fees, then only bidder will become eligible to submit the e-auction documents.

- 7) Except the sheds / Buildings mentioned on Page No.3 of e-Auction form, other sheds / Buildings are not included in this e-auction.
- 8) After demolishing the sheds / buildings as mentioned on page No.3, successful bidder should take out the materials and level the place.
- 9) Successful bidder is required to take the permission from Nagpur Municipal Corporation for demolishing the sheds / buildings. The documents required, if any, will be provided to the Successful bidder. Responsibility of taking permission will be of the Successful bidder.
- 10) e-Auction form is not transferable to others.
- 11) Prescribed e-Auction form will have to be submitted on line on web site of www.eauction.gov.in during specified period as mentioned on Page No.2.
- 12) Physical copy of the E-Auction Form will have to be submitted to the MSTC at its registered office within specified period as mentioned on Page No.2 alongwith EMD of Rs.15,00,000/- (Rupees Fifteen Lacs only), and Rs.1,500/- (Rs. One thousand Five Hundred) towards cost of e-Auction form by way of separate Demand Draft/Pay Order only, drawn on Schedule Bank and be drawn in favour of "MAHARASHTRA STATE TEXTILE CORPORATION LTD." payable at Mumbai.
- 13) **Guidelines for e-auction are annexed separately which shall form part and parcel of the e-Auction CONDITIONS**
- 14) i) **RESERVE PRICE:**

There shall be a reserve price which is strictly confidential. If after the completion of the bidding process it is found that the highest bid is less than the reserve price, the entire auction shall be cancelled.
- ii) **STARTING PRICE:**

There shall be a 'Starting Price' for auction which will appear on the e-auction portal at the time of auction. Bidders are required to quote bids for the value of all Sheds / Buildings together. **The starting price has been fixed as Rs.153.00 lakhs.** However, starting price shall not be interpreted as the reserve price of Sheds/Buildings to be demolished.

The reserve price of the Sheds/Buildings shall be confidential so that the auctions do not get influenced by the reserve price. The starting price is the minimum amount from which the bidding shall start and have no other significance apart from being the starting point of auction.

iii) Live-e-auction-Bidding Methodology:

On the date of auction as per schedule mentioned in at page 2, auction will commence at 11.00 a m. Approved bidders will be eligible to participate in auctions. On the beginning of e-auction, a starting price shall appear. The increment value shall be minimum of Rs. 2,00,000.00 (Rs.Two Lakh only); hence the next bid has to be higher by Rs.2,00,000.00 (Rs.Two Lakh only) of the previous bidding price. However, the bidders are free to increase the bid price by more than Rs.2.00 Lakh but in the multiple of Rs.2.00 Lakh.

Illustration: Say for example, the previous bid price is Rs.153.00 lakhs. The next bid should at least Rs 155.00 lakhs.

Bid will be closed at 3.00 (three) pm. However, if there is any bid within 10 minutes of the closing time then the closing time shall automatically be extended by the system by 10 minutes and shall continue to extend till there is no bid within last 10 minutes of the closing time.

iv) EVALUATION OF THE AUCTION: After completion of bidding, if it is found that the highest bid is more than or equal to the reserve price, the Letter of Acceptance will be allotted to the highest eligible bidder subject to approval of the Board of Directors of MSTC

- 15) e-Auction Documents submitted by the bidders will be scrutinized by MSTC. In case the bidder has mentioned some other conditions in the e-Auction Documents then such documents will be rejected. After scrutiny of the e-auction documents, the EMD amount of the bidders who are not eligible for e-auction will be refunded to them only after completion of the e-auction procedure. After e-auction, the EMD amount of highest three bidders will be retained by MSTC. The EMD amount of the remaining bidders will be refunded to their bank account. The EMD amount of other two bidders will be refunded in their Bank Account within 60 days or 7

days from the date of issuing letter of acceptance to the successful bidder and on depositing the entire bid amount by him with the Corporation, whichever is earlier.

- 16) Under any circumstances, right will not be available to the first, second and third highest bidders to withdraw their offers during the period of 60 days from the date of e-auction. Their EMD amount shall continue to remain with MSTC without interest.
- 17) Apart from the bid amount, the Successful Bidder will be responsible to make the payment of taxes either service tax or GST and other taxes applicable in Maharashtra State.
- 18) The successful bidder whose bid is accepted will have to pay full bid amount plus applicable tax amount within 15 days from the date of issuance of Letter of Acceptance with the Admn. Office at Nagpur by Demand Draft in the name of Maharashtra State Textile Corporation Ltd. payable at Mumbai. If the Highest Bid amount and tax amount is not deposited within 15 days, then the Letter of Acceptance will be cancelled and EMD amount of Successful Bidder will be forfeited.
- 19) The highest bid amount submitted by the successful bidder will be bifurcated as under for determining the tax liability :

1)	Iron Scrap	90% of the Highest Bid Value (Nearest to '000)
2)	Wooden Scrap	1% of the Highest Bid Value (Nearest to '000)
3)	Other Building Materials/Scrap	9% of the Highest Bid Value (Nearest to '000)
4)	Total :-	100% of the Highest Bid Value

- 20) The successful bidder has to lift the material covered under the e-auction at his cost from the place within 150 days from the date of depositing the bid amount. In case material is not lifted within the aforesaid stipulated time then Management will extend the period of 30 days, however, 2% amount towards ground rent on the cost of remaining material will be charged while taking out the material during extended period. And in case the material is not lifted within total period of 180 days then this Letter of

Acceptance be cancelled and EMD amount plus **amount deposited will be forfeited** and will not be allowed to take out the remaining material.

- 21) The Successful Bidder will not be permitted to take out the material by digging below surface level.
- 22) EMD amount of Rs.15,00,000/- (Rs. Fifteen Lakh only) will be refunded to the Successful Bidder through their Bank account after completion of work as per e-Auction Terms. While refunding the EMD, the amount to the extent of loss caused to the Corporation will be deducted and balance amount will be refunded.
- 23) After depositing the entire bid amount with taxes and executing the Agreement on stamp paper of Rs.500/- containing e-Auction Terms and Condition, the successful Bidder will be entitled to demolish the shed / Building and take out the material at his cost and risk. Likewise after receiving the letter of acceptance and depositing the entire bid amount with taxes, the responsibility of protecting the material will be that of the Successful Bidder.
- 24) The Successful Bidder will be responsible in case any injury or accident is caused to the workers engaged by the Successful Bidder while demolishing the Sheds/Buildings, taking out and carrying out the materials, Corporation will not be responsible. The Successful Bidder should give the written undertaking to the management in this regard before starting the work.
- 25) Before demolishing the sheds / buildings, the Successful Bidder will have to submit the list of the workers engaged by him together with their photographs, their residential address, police verification certificate, Xerox copies of policy/s taken out under Workmen's Compensation Act or under Group Insurance Policy to the Management.
- 26) The Successful Bidder will be required to bring the materials required for demolishing the sheds / Buildings.
- 27) The Successful Bidder will be allowed to demolish the Sheds/Buildings mentioned in e-Auction Document and take out the materials during the period from 8.00 A.M. to 6.00 P.M. including the days of holidays.

- 28) Before submitting the e-auction documents, the prospective bidders should inspect the Sheds/Buildings. Only after inspecting the Sheds/Buildings mentioned on Page No. 3, the Bidders should submit online e-auction documents. It will be presumed that the e-auction documents are submitted by the bidders, only after inspecting and satisfying themselves about the conditions of the Sheds/Buildings which are being offered for demolition on "as is where is" basis,
- 29) Letter of acceptance will be cancelled and EMD will be forfeited because of the following reasons:-
 - a. In case it is felt that Successful Bidder is not doing the work as per e-Auction Conditions.
 - b. The behavior of the Successful Bidder or his representatives is not proper.
 - c. The Successful Bidder or his representatives has attempted to theft.
 - d. Work is not completed within prescribed period.
- 30) The work relating to demolition of Sheds / Buildings and taking out the material will be started only after depositing the entire Bid amount together with applicable tax amount.
- 31) The letter of acceptance issued to the Successful Bidder is not transferable to other person.
- 32) The bids received in the e-Auction are subject to the jurisdiction of Nagpur Judiciary.
- 33) The Successful Bidder or his representative will be allowed to enter the place where the Sheds / Buildings are to be demolished, and will not be allowed to enter other places.
- 34) While demolishing the Sheds/Buildings and taking out the material, official representative will remain present in whose presence Successful Bidder shall execute the work.
- 35) Successful Bidder will have to get prepared the Gate passes from the office while taking out the materials.
- 36) Maharashtra State Textile Corporation Ltd. is empowered to cancel the e-Auction process without assigning any reasons thereof.

- 37) In case of any disputes is raised by the Successful Bidder, the decision given by the Managing Director of the Maharashtra State Textile Corporation will be final and binding.
- 38) It will not be binding on the part of Maharashtra State Textile Corporation Ltd. to accept the highest bid amount received in e-auction. Likewise if the bidder has put some conditions in bid documents then such bid shall be cancelled.
- 39) If the Successful Bidder desires to take out the materials through his representative then he should submit the identity card of representative and letter of authorization to the MSTC' s Administrative Office at Nagpur.
- 40) It is presumed that the Successful Bidder has submitted his e auction documents after examining the e-Auction conditions which are part and parcel of the e auction document and are acceptable to the Successful Bidder.

GUIDELINES FOR E-AUCTION**

AUCTION PROCESS:

- REGISTRATION OF BIDDERS
- E-APPLICATION FOR INDIVIDUAL AUCTION & UPLOADING OF SCANNED COPIES OF DOCUMENTS.
- SUBMISSION OF HARD COPIES AT AUTHORITY'S OFFICE.
- APPROVAL BY AUTHORITY
- LIVE e-AUCTION.
- EVALUATION OF AUCTION PROCESS.

1. Registration of Bidders:

To participate in the e-Auction, it is mandatory for the Bidders to make one time enrolment (register on the website) on the e-Auction portal at www.eauction.gov.in. Bidders shall require Class III Digital Signature Certificate (DSC) with Signing Certificates to participate in this e-auction. The bidder shall have to set the parameters of his computers so that the DSC is operational.

1.2 E-Application for Individual Auction & uploading of scanned copies of documents:

(A) Technical Bid / Cover

Intending bidders who have registered at the e-auction portal as mentioned above have to apply by filling up the form that will be available at the concerned webpage and following scanned documents need to be uploaded.

- (i) Scanned copy in pdf format of duly filled up application format available with this Bid Document.
- (ii) Scanned copy in pdf format of online generated payment receipt relating to EMD and cost of e-Auction form.
- (iii) In case of company, scanned copy in pdf format of Certificate of Incorporation under the Companies Act, 1956 or 2013.
- (iv) Scanned copy of PAN card of the applicant.
- (v) In Case of Partnership firm, scanned authorization letter of the partner and scanned copy of certificate of registration of the Partnership firm need to be uploaded in addition to abovementioned documents.

1.3 Submission of Hard copies at Authority's office:

1.4 Approval by authority:

On submission of the online application and after submission of hard copies of documents within specified date & time, MSTC will verify whether eligibility criteria has been fulfilled and all specified documents, cost of e-Auction form and EMD are duly & properly submitted and thereafter approval to participate in the online auction will be issued.

1.5 Live-e-auction-Bidding Methodology:

On the date of auction as per schedule, auction will start. Approved Bidders will be eligible to participate. On the beginning of e-auction, a starting price shall appear. The increment value shall be more than Rs. 2,00,000/- (Rs. Two Lac only); hence the next bid has to be increased at least by Rs. 2,00,000/- (Rs. Two Lac only) of the previous bidding price. However the bidder can increase his bid upward by minimum of Rs. 2,00,000/- (Rs. Two Lac only) or in Multiple of Rs.2,00,000/- (Rs. Two Lac)

Bid will be closed at 3.00 (three) pm. However, if there is any bid within 10 minutes of the closing time then the closing time shall automatically be extended by the system by 10 minutes and shall continue to extend till there is no bid within last 10 minutes of the closing time.

2. USE AND PROTECTION OF USER ID, PASSWORD AND DIGITAL SIGNATURE CERTIFICATE:

The bidders are advised to keep their User Id and Password secret and not share these with anyone to prevent misuse or abuse of the same. The bidders are also advised to change their passwords regularly. MSTC shall not be responsible for any misuse / abuse / unauthorized use of the password of any bidder and no representation in this regard from any bidder shall be entertained by MSTC.

3.CAUTION FOR SUBMISSION OF BID:

The Bidder shall be solely responsible for all consequences arising out of the bid submitted by him (including any wrongful bidding by him) and no complaint/representation will be entertained by MSTC in this regard. Hence Bidders must be careful to check (the Bid Amount/No. of Zeros /No. of Digits) and to rectify their bid (if required) before submitting their Bid into the live e-Auction floor.
